SECTION 4. First aid measures.

4.1. Description of first aid measures.

SECTION 6. Accidental release measures.

SECTION 7. Handling and storage.**7.1. Precautions for safe handling.**

Before handling the product, consult all the other sections of this material safety data sheet. Avoid leakage of the product into the environment. Do not eat, drink or smoke during use. Remove any contaminated clothes and personal protective equipment before entering places in which people eat.

Store only in the original container. Store the containers sealed, in a well ventilated place, away from direct sunlight. Keep containers away from any incompatible materials, see section 10 for details.

SECTION 8. Exposure controls/personal protection.**8.1. Control parameters.**

During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for inert particulate not otherwise classified (PNOC respirable fraction: 3 mg/m³; PNOC inhalable fraction: 10 mg/m³). For values above these limits, use a P type filter, whose class (1, 2

or 3) must be chosen according to the outcome of risk assessment.

8.2. Exposure controls.

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration. Personal protective equipment must be CE marked, showing that it complies with applicable standards.
